WORK OF THE DEPARTMENT

The 2020 - 2021 academic year was a very challenging one for the Mona Academy of Sport as the ongoing Covid19 pandemic created significant disruptions for much of our operations. A total of 104 offers were made for our two undergraduate programmes (Sport Coaching and Sport Kinetics) however many declined due to financial constraints imposed by Covid 19. Despite this we remained relatively stable with 47 new enrolments. The courses in these programmes were delivered using the Cross-Campus platform with students from the St. Augustine and Mona Campuses being taught together. Two courses were delivered by lecturers employed to the St. Augustine campus and all others were delivered by Mona lecturers. There were several problems with the CCM platform in semester 1 which adversely affected teaching in the first month however these were eventually resolved with minimal issues in semester 2. The biggest challenge for lecturers and students was internet connectivity. To reduce the impact of this all sessions were recorded so students could access content whenever they had connection. The MSc. Sport Business management got off to a successful start in semester two and the MSc. Sports Medicine and MSc. Sports and Exercise Medicine continued to run smoothly. With the ongoing pandemic a decision was made to hold virtual practicums for both year groups to minimize delays in programme progression. Students participated in two full weeks of synchronous sessions with a few coming onsite in Jamaica to be models for streamed demonstrations. Overall, it was successful. Though students indicated that the onsite format was preferred they were satisfied with the sessions. The MPhil/ PhD programme continued to run smoothly. Focus was also placed on having our graduate students write for the faculty's

column in the Trinidad Guardian (Sport Matters). Seven students of the Academy had articles that were published this year.

Throughout the 2020-2021 academic year, we continued to build and nurture relationships with external sporting organizations by delivering virtual educational sessions to their athletes. Most organizations ceased all training activities except for cricket and the Sports Medicine Clinic continued to provide medical/rehabilitation services for the Jamaica Cricket Association. In July 2021 we signed an MOU with the newly established Powerlifting Association of Jamaica. The personal training services at the Clinic continued but with much disruption due to numerous Covid 19 restrictions. Our UWI Moves programme (a low-cost wellness initiative delivered at the Mona Bowl) was launched but uptake remains low due to Covid 19. All sporting activities were suspended for the year except for track and field and football. The track and field athletes maintained high levels of performance. Two were selected to represent Jamaica at World Relays, however, the country withdrew from participation at the last minute. Three of our current student athletes represented Jamaica at the Olympics and two won bronze medals in the 4x400m relays. Two of the recent graduates, who continue to train at the bowl, also made the Olympic team and one obtained a gold medal in the 110m hurdles. Football training was highly disrupted due to government and Jamaica Football Federation restrictions. The academy eventually had to withdraw from the Premier League which did not begin until the academic year had ended. Several staff development activities occurred during the year. During the period November to December 2020 weekly staff engagement activities were conducted. This included physical activity-based team building sessions along with a series of presentations on our business plan and expectations going forward.

A training exercise was conducted for the pool staff in August 2020, however the pool was subsequently closed due to financial constraints. Five staff members attended the ACHEA Barbados Chapter Presentation on "Maintaining Quality Service in a COVID-19 Climate" in August 2020 and one attended the ACHEA Webinar-Google Meet for Administrators in May 2021. The Sports Medicine Clinic staff participated in a Virtual JADCO Workshop on November 24, 2020. Fiona Binns completed the Jamaica Cricket Association's Team Mangers Certification Course and Dr. Olivia Rose completed the online JAAA COVID-19 Protocol Certificate for the return of sport put on by the Ministry of Health and Wellness. Staff also attended seminars organized by the Administrative Officers of the Faculties on estate management and life planning and Michelle Smith attended the "Creating Caribbean Champion" Virtual Workshop in March 2021. One senior staff member left the academy in October 2020 and a replacement remains to be identified. Shara Creary Yan obtained her certification by the International Lymphedema and Wound Training Institute in lymphedema management, wound therapy and compression garments.
