OVERVIEW

The academic year 2020/2021 was extraordinary and unforgettable. The health crisis demanded that major adjustments be made to remain relevant and deliver our services in a satisfactory manner. We were obliged to strive to fulfil our mission in the midst of a pandemic. SALISES also lost two of its alumni: Ms. Greta Bogues and Dr. Pauline Knight and four SALISES staff lost family members. In spite of the various challenges, the academic year was a successful one. The significant outputs by staff in 2020/2021 proved that our SALISES staff is committed and resilient. We were able to successfully transition from a face-to-face delivery of our graduate programmes to online mode. SALISES Research Staff also produced a significant amount of research and engaged in numerous intellectual public engagements. We were able to meet our strategic targets and over-performed in some areas.

ACCESS

Fortuitously prior to the pandemic, we had received approval to change the MSc in Development Studies to online mode. The first year of the new online MSc programme was delivered during a pandemic and with many challenges faced by staff and students. In 2020/2021, SALISES received 102 applications for its MSc programme; an increase of 9% over 2019/2020. Thirty-six new students registered for the new online MSc programme. That figure represented an 263% increase over the previous academic year. Our new

students hailed from several countries including the United States of America, the United Kingdom and the Caribbean. The first year of the online MSc programme was successful and the lecturers, students and academic staff are to be lauded for their valiant efforts. We will also graduate 8 MSc students (5 with distinction) in November 2021.

ALIGNMENT

The research output for the academic year: 2020/2021 was impressive with 12 journal articles, 1 edited book, 7 book chapters. Dr Natalie Dietrich Jones, was awarded Most Outstanding Research. Fellow prize for the year 2020/2021 with two journal articles and two book chapters. SALISES staff also presented at 15 conferences/seminars. Dr Dacia Leslie received the Principal's Award for Best Faculty of Social Sciences Publication, for the Academic year 2019/2020 for her book, 'Recidivism in the Caribbean - Improving the reintegration of Jamaican Ex-prisoners'. Professor Aldrie Henry-Lee, University Director received the VC's Award for All Round Excellence. In Research, Teaching and University Service.

AGILITY

SALISES Staff continued to be sought after for commissioned projects and SALISES staff began three new commissioned projects. They were also invited to sit on several international, regional and local organization because of their specialized skills. SALISES staff also organized 19 online seminars and forums. The Caribbean Child Research Conference, (the only conference that provides child and adult researchers, equal voice) had its 15th hosting. The output for the academic year was outstanding and the SALISES Team members are to be highly commended for their achievements during a pandemic.

Derek Gordon Databank

The Derek Gordon Databank continued to offer support for academic research and teaching by providing over 120 micro-data sets to students, lecturers and researchers during the period.

Norman Girvan Documentation Centre

The Norman Girvan Documentation Centre shifted operations to provide online support for staff and students. Librarians provided subject support for teaching and research, by promoting subject e-resources, Open Education Resources (OERs), and facilitating digital reproduction and supply of needed print resources in keeping with copyright restrictions. In addition, limited in-person services were provided to faculty and graduate students, especially for print resources which were not available in e-formats. Loan of select print resources was facilitated by curb-side delivery to faculty and graduate students. The Library also expanded access to critical print resources not available in e-format or for loan by digitizing sections as requested by faculty and graduate students to support research and teaching. Librarians also conducted online citation and thesis consultations and developed relevant subject guides to support online teaching. Two new collections were acquired: the Trevor Munroe collection of books and papers, and a smaller collection from UNICEF. The digitization of the Erna Brodber Oral History Project which began in early 2020 was completed in December.

Publications Section

The special issue on Reparations (Volume 68: 3&4) was launched virtually on January 23, 2021 by the Centre for Reparations Research in collaboration with SALISES, Mona. Professor Sir Hilary Beckles, Vice Chancellor made opening remarks and the launch was moderated by Professor Verene Shepherd. The guest speaker was Dr. Michele Johnson of York University, Canada. The latest issue of the Social and Economic Studies(SES) Journal Volume 69: 1&2 March/June 2020, General issue is now available. Volume 69: 3&4 September/December 2020, The Quest for Sustainable Caribbean Futures, guest edited by Dr. Patricia Northover, Senior Research Fellow is now in press.

ACCESS

SALISES sought to increase access for students by the conversion of the MSc Development Studies programme from face-to-face delivery mode to an online delivery platform. This transformational activity was a success and the new programme commenced on September 14, 2020. Marketing efforts led to SALISES achieving its recruitment target of 36 registered students for the 2020/2021 academic year, resulting in a 263% increase in enrolment compared to the previous academic year. Seven new students registered for the MPhil/PhD programme. The Global Partnership Network (GPN), is one of the centers of Excellence for Exchange and Development funded by the German Federal Ministry for Economic Cooperation and Development (BMZ) through the Higher Education Excellence in Development Cooperation (EXCEED) program of the German Academic Exchange Service (DAAD). It is an assemblage of higher education institutions and civil society groups for research, teaching and training around SDG 17: "Strengthen the means of implemen-

tation and revitalize the global partnership for sustainable development". The GPN targets research, teaching and training that investigates the global partnership for sustainable development. The University of the West Indies, through the Sir Arthur Lewis Institute of Social and Economic Studies, SALISES, as a collaborating partner in this consortium of universities has partnered to provide the GPN- Arthur Lewis Annual scholarship over the period 2020-2024. The award will generally be for the sum of USD750.00 per month, for a minimum period of 3 months. Students pursuing the MSc Development Studies programme are eliqible for this award.
