## SURMOUNTING THE CRISIS

In the spirit of the axiom, “never waste a crisis”, the department continued its efforts to support the Triple A Strategy of UWI in enhancing teaching and learning, promoting digital transformation, promoting research, implementing strategies to bolster the financial health of the institution and public service.

### ENHANCING TEACHING AND LEARNING

We strengthened our efforts to innovate in order to enhance the teaching and learning process amidst the pandemic. We introduced the Fellowship in Child and Youth Psychiatry and through our advocacy have received support from the Ministry of Health & Wellness in regards to the Family Medicine Programme and introduced many novel approaches to support undergraduate and graduate programmes.

### ENHANCING RESEARCH AND PUBLICATION

Despite the challenges, the department published thirty-seven (37) peer reviewed journal articles, which represents a modest 16% over the previous year. In addition there were two (2) book chapters, six (6) technical reports and over (25) presentations were made.

### CONTRIBUTION TO THE FINANCIAL HEALTH

The department continued its effort in implementing the cost containment plan to support the university thrust towards maintaining the financial health of the institution.

### PUBLIC SERVICE AND COVID RESPONSE

Many staff members continued to give sterling contribution in the public arena especially in the area of Public Health to support national efforts to contain the COVID pandemic.

This first cohort had on average of 33 registered students at each session joining from countries such as Jamaica, Trinidad and Tobago, and Barbados. Tutors were each rated 5/5 by students.
