– Dean's Overview –

Dr Leighton Jackson began his second year as the second Dean of the Faculty of Law at Mona. Under his leadership, the Faculty continued to enrich the students' experience, provide continuing legal education activities and to impact the wider society through outreach initiatives.

The Faculty hosted its Fourth Annual Weekend Symposium on Law, Governance and Society under the theme "Development: As the World Turns So Should the Law" from June 15–17, 2018 at the Spanish Court Hotel in Kingston. The symposium featured speakers from the United Kingdom, the United States of America, South Africa and Jamaica. The local presenters included students in undergraduate and graduate programmes in the Faculty, members of academia, the judiciary and others in the legal fraternity. The keynote speaker was Professor Trevor Munroe, Executive Director of National Integrity Action (NIA).

The third volume of the *Journal of Law, Governance and Society* was published. This Faculty journal which was launched in 2017, comprises articles based on papers presented at the annual symposium.

The Faculty published the fifth volume of the MonaLaw Report: *Opinio Juris*, showcasing some of the activities in the Faculty during the 2016/2017 academic year. The MonaLaw Report is used as an outreach and marketing tool for the Faculty and is widely circulated.

TEACHING, LEARNING, STUDENT DEVELOPMENT AND ACHIEVEMENT

The Faculty had its first graduates from the Master of Laws (LLM) programme offered by the Faculty. Two students completed the requirements for the LLM in Corporate and Commercial Law and Public Law, respectively. The Faculty also graduated 143 undergraduate students, 21 of whom were awarded the LLB with First Class Honours.

For the 2017/2018 academic year, the Faculty welcomed its largest intake of 251 Bachelor of Laws (LLB) students; 11 of these students completed year one of the programme at the Western Jamaica Campus. During the year, the Faculty continued to identify and implement strategies aimed at improving the students' experience and equipping them to perform at their optimum. These initiatives included providing additional tutoring and revision sessions for students who were identified as being 'at-risk'.

In an effort to provide greater support for students, the Faculty sanctioned the award of Mona Law Bursaries valued at approximately thirty-three million dollars (\$33,000,000) during 2017/2018.

The Faculty prepared five teams to participate in international and regional mooting competitions. This initiative was introduced under the leadership of the first Dean of the Faculty (Dr Derrick McKoy) and has continued. This opportunity allows for greater exposure and development of the team members and wider recognition for the University. In 2017/2018, the Faculty participated in the Frankfurt Investment Arbitration Mooting Competition with the team coached by Mrs Caprice McFarlane-Morrison; the Inter-American Moot Competition with coach Mr Jermaine Case; the International Criminal Court (ICC) Moot Court Competition with coach Mrs Kamille Adair-Morgan; the Caribbean Court of Justice (CCJ) Moot Competition with coach Dr Emir Crowne and the Price Media Moot Competition with coach Ms Gabrielle Elliott-Williams.

The MonaLaw team was placed in the top 6 out of 41 teams at the Price Media Moot Competition and at the CCJ Moot Competition was

awarded 'Best Academic Institution' of the 5 law Faculties in the Caribbean, who competed. It is noteworthy that all members of the Norman Manley Law School (NMLS) moot team, which was the overall winner of the CCJ Competition, comprised recent graduates of UWI, the majority of whom were from MonaLaw.

The Faculty continued to work closely with the executive body of the Mona Law Society (Law Faculty students' association) to effect changes in the best interest of the students and to ensure the best opportunity is created to produce a well-rounded graduate. From this partnership, a mentorship programme was re-introduced; funds were raised for a needy students fund through various initiatives such as an OpenEar Concert, the hosting of a drama production by Mr and Ms Law 2017 and other activities.
