OVERVIEW

In October 2021, Shazeeda Ali was promoted to the rank of Professor and continued her tenure as Dean of the Faculty of Law. Under her leadership, the Faculty sought to further enrich the students' learning experience, provide continuing legal education activities and to positively impact the wider society through numerous outreach initiatives.

ACCESS

Student Achievement

Ten students from the Master of Laws (LLM) programme have completed the degree, one of whom will graduate with distinction in the Public Law concentration. 178 students from the undergraduate programme have completed the LLB degree, 15 of whom were awarded with First Class Honours. During the 2021/2022 academic year, the Faculty continued to identify and implement strategies aimed at improving the students' experience. The 4th Annual Faculty Awards Ceremony for the recognition of outstanding students in academia and co-curricular activities was held virtually for the second time on November 8, 2021 with 103 students being recognized in the categories of Subject Awards, Year/Level Awards, Top LLM Student Award and Dean's List Award.

In June 2022, the Faculty had its first hybrid staging of its Eighth Annual Weekend Symposium on Law, Governance and Society under the theme 'Redefining Boundaries in the Context of Global Justice'. It featured panels dealing with Criminal Justice, Geographical Indications, Nuclear Law, Legal Professional Ethics and Indigenous Rights. The event was held online via Zoom and in-person at the Courtleigh Hotel from Saturday, June 25 to Sunday, June 26, 2022. The Keynote speaker for the event was Dr. Derrick McKoy, CD, QC, Attorney General of Jamaica and former Dean of the Faculty of Law. The Minister of Justice, the Honourable Delroy Chuck, delivered a virtual presentation during the panel on Criminal Justice. The symposium featured speakers from The USA, the UK, Barbados and Jamaica On March 28, 2022, the Faculty hosted its third annual Career Forum 3.0 virtually, with the aim of increasing students' awareness about the various career paths available after completing the LLB degree. This took the form of a panel discussion with persons from several professions, where some of the

career options require the Legal Education Certificate (LEC) and others do not. The graduate arm of the Faculty continued to promote special admission to the LLM programme. This initiative has capitalized on the market demand of practitioners for one or two specialized courses. The Faculty has also been able to admit students, who were initially specially admitted, to the LLM programme after completing one or two courses as specially admitted students. There were 19 students enrolled as specially admitted students in each semester during 2021-2022.

Regional and International Collaboration

a. Collaboration with Georgetown University's O'Neill Institute
Collaborations were established, through the Office of the Deputy Dean,
Graduate Studies and Research, with the O'Neill Institute for National and
Global Health Law at Georgetown University Law Centre and the Faculty
of Law at Cave Hill and St. Augustine. The Institute's discussions with MonaLaw were supported by the Office of Global Affairs, and a memorandum
of understanding was established between the Institute and The UWI to
work together on legal scholarship, capacity building and technical assistance related to food law.

b. Nuclear Law Programme. The International Atomic Energy Agency (IAEA), an agency of the United Nations, hosted its first International Conference on Nuclear Law from April 25 to 29, 2022, in Vienna, Austria. The IAEA invited The UWI to be one of five universities selected globally to introduce a Nuclear Law certificate programme. At the ceremony, Dr. Natalie Corthésy, Associate Dean, Outreach and Continuing Legal Education, signed the partnership agreement on behalf of The UWI with the IAEA. Dr. Corthésy and Legal Counsel for The UWI Hospital, Dr. Peter Glegg, represented the

University at the Conference. It is anticipated that the Nuclear Law programme will be offered jointly by the Faculty of Law, the Faculty of Medical Sciences and the Faculty of Science and Technology, Mona.
