WORK OF THE DEPARTMENT

The Institute of Education continued to focus on the quality assurance of programmes and institutional strengthen- ing of teachers colleges, research, graduate studies, and services to the education sector. Targets were met in the provision of staff development workshops for teachers colleges, and in the assessment of the practicum in Jamaica, Belize, the Bahamas and Turks and Caicos Islands. The Institute continues to deliver graduate programmes and courses in



the School of Education and to provide administrative support for graduate studies.

INSTITUTIONAL STRENGHTENING OF COLLEGES AND RELATED ACTIVITIES

Activities in the Western Caribbean

The Institute of Education, through the Joint Board of Teacher Education (JBTE), continues to provide sterling quality assurance services for teachers colleges in the Western Caribbean. The following are the main activities completed during the past academic year:

Belize

Dr. Marcia Stewart represented the JBTE at the meetings of the Belize Board for Teacher Education held in October 2006 and May 2007.

In May 2007, Drs. Marcia Stewart, Lorna Down and Nadine Scott led the team that assessed final year student teachers completing their Teaching Practice from University of Belize, St. John's Junior College, Corozal Junior College, and San Ignatius Junior College. Dr. Rose Davies gave external review of the A.Sc. degree in Early Childhood Education developed by St. John's Junior College.

College of the Bahamas

Dr. Halden Morris, Professor Hyacinth Evans and Miss Joan Tucker participated in the external evaluation of Teaching Practice of final year student teachers at the College of the Bahamas during March 2007. The team also held discussions with the staff of the College regarding supervision and a joint collaborative research on student teachers.

Turks and Caicos Islands Community College (TCICC)

Dr. Moses Peart led the Teaching Practice external review team for final year students of the TCICC's A.Sc. in Primary Education.

Dr. Moses Peart led a workshop on Instructional Design for lecturers of TCICC in order to set groundwork and give guidance for the development of their associate degree for secondary teachers.

Dr. Marcia Stewart met with the coordinator of TCICC's teacher education programme to give further assistance in the development of their secondary programme.

Jamaica

The annual professional conference focusing on the theme of "Quality for Transformation" was organized and co-ordinated by the JBTE for staff of the teachers colleges and members of the Institute of Education. About 350 persons attended this conference.

All academic members of staff were involved in the teaching practice exercise which was led by Dr. Lorna Down and Dr. Nadine Scott in February 2007.

Work continued in collaboration with college lecturers to review the criteria for assessment in language in order to strengthen comparability across colleges where standards in performance in English are concerned. The operationalization of the JBTE language policy across teachers' colleges also continued.

JBTE led the development of the framework for training Spanish teachers for the primary school system and a programme for training teachers of Spanish for the primary schools was developed.

Through JBTE intervention, colleges offering programmes for the secondary system were included in the eLearning project of the Ministries of Education and Ministry of Technology to improve teaching/learning quality in secondary schools.

New Relationships

On the invitation of Colbourne College in Westmoreland and the International University of the Caribbean (IUC) visits were made to initiate membership of these institutions in the JBTE. Membership has since been formalized for the IUC.

Other Regional/International Activities

A Regional conference was held in Belize with participation and papers from Bahamas, Belize, Jamaica and Turks and Caicos islands;

Dr. Marcia Stewart represented the JBTE and the Ministry of Education in a Working Group convened in Pretoria, South Africa, by the Commonwealth Secretariat, to act on the directives of the 15th Conference of Ministers of Education Meeting that the Secretariat should seek to identify ways through which Commonwealth citizens can have greater access to teaching in other Commonwealth countries.

Miss Joan Tucker and Dr. Marcia Stewart were appointed members of the CARICOM Working Group to set up regional mechanisms for teacher education. They attended two meetings.

Professor Hyacinth Evans attended an expert panel meeting to plan for the International Education Association's assessment of Mathematics Teacher Education. The meeting was held in Grand Rapids, Michigan September 28 to October 1, 2006.

PUBLICATIONS UNIT

The Unit which comprises Publications Officer Ms. Sonia Chin and Production Assistant Ms. Sherron Duffus published two issues of the Caribbean Journal of Education one of which was a special issue which focused on the Organization of Eastern Caribbean States (vol. 28, no. 1) and the second was a general issue (vol. 28, no. 2).

PROJECTS AND DEVELOPMENTAL WORK

The JBTE HIV Initiative

There is an urgency for teacher education to become directly involved in HIV and AIDS education. Therefore, the JBTE and the Institute of Education propose to address the HIV/AIDS dilemma through the Children's Institutions Outreach and the JBTE HFLE: HIV and AIDS Project, as part of the national initiative.

The JBTE HIV Children's Institutions Outreach

The JBTE HIV Children's Institutions Outreach is funded by the Environmental Foundation of Jamaica under the theme 'Child Survival and Development'. Vileitha Davis-Morrison and Janice Holung are the Researchers and Facilitators. The project includes six teachers colleges that specialize in early childhood or primary teacher education and seeks to provide care-givers, teachers and student teachers with the strategies to teach STIs including HIV and AIDS, to ensure proper care for HIV infected/affected children and to reduce discrimination against persons infected/affected by HIV and AIDS.

Global Fund: JBTE HFLE: HIV and AIDS Project

Project Director Vileitha Davis-Morrison and coordinator Mrs. Janice Holung continue the work of the JBTE HFLE: HIV and AIDS Project founded by the Global Fund for the period September 2006 - May 2007. JBTE is a sub-recipient in the Global Fund project. This project seeks to institutionalize HFLE: HIV and AIDS education into the formal and informal curricula in three new teachers' colleges and the former five colleges, using the whole school and outreach approaches.

Advancing Biodiversity Education in Teachers' Colleges

This project is directed by Mrs. Marceline Collins-Figueroa (JBTE/IOE) and Miss Carlette Falloon of the Jamaica Environment Trust and is sponsored by the Environmental Foundation of Jamaica for 2005-2007. This biodiversity action project was implemented to infuse biodiversity education in a number of subjects in the early childhood, primary and secondary programmes in nine teacher education institutions. The project was recently extended for 15 months.

Environmental Education for Sustainable Development

Directors: Mrs. Marceline Collins-Figueroa and Dr. Lorna Down. With funding from the governments of Jamaica and Canada, the Sustainable Teacher Environmental Education Project (STEEP) of the JBTE/IOE was extended to 2008. Workshops were held to infuse education for sustainable development (ESD) into JBTE curricula and to extend the whole college approach to ESD into two more teacher education institutions. An environmental education course was designed and written for the JBTE early childhood and primary teacher education programmes.

Development of Grade-Four Numeracy Test

Project coordinator: Mrs. Ceva McPherson-Kerr. Expanding Educational Horizon (EEH) Project A is a joint initiative of the Government of Jamaica and the United States of America through their monitoring agencies MOEY&C and the United States Agency for International Development (USAID). A Grade-Four Numeracy Test (GAIN Test) has been developed.

Information and Communication Technology

A strategic objective of the Institute is to enable the education community of the region, and in particular the teacher education sector, to design, develop and deliver high quality academic and professional teacher education programmes that meet international standards, consistent with one of our missions, to support, facilitate and promote teacher education in the Region. The Institute of Education through the Joint Board of Education (JBTE) has therefore invested significant resources in its information technology infrastructure, which now includes a bank of modern servers outfitted with sophisticated software and peripherals to ensure efficient and sustainable ICT capabilities; and a robust Wireless Wide Area Network (WWAN).

The IOE technology infrastructure includes: On-line course delivery systems such as Virtual University and the Modular Object Oriented Distance Learning Environment, MOODLE; E-mail and Messenger Services in which all member institutions of the JBTE can deploy their e-mail and messenger services through the JBTE servers. The services are dedicated to the institutions served and the domains are deployed accordingly. All lecturers and administrators are given free e-mail services on the system; there is access to on-line publications & library highlighting some publications – the IOE Publication Series – the official journal of the Institute, as well as the Caribbean Journal of Education, the official Journal of the School of Education. Also available on this system are restricted access to PROQUEST, an on-line library facility; and College Information System (CIS) a new college information system through the JBTE. The system is being configured to collect demographic and other information from all college students and feed this information to the JBTE, thus replacing a dated college manager system that was initiated some 15 years ago.

The Wireless Wide Area Network (WWAN), a broad-band wireless wide area network currently links all teachers colleges except the College of Agriculture Science and Education (CASE). The system is capable of delivering synchronous video, voice and data. The IOE Local Network and EduLab support the wider educational community. The Institute maintains a small Local Area Network to supply connectivity and workstation support to some 23 staff offices located in the School of Education building. It also facilitates a small IT training laboratory of about 12 unit stations, known as EduLab, for the training and development of our own staff as well as small groups of stakeholder personnel.
