DEAN'S OVERVIEW

Dr. Shazeeda Ali continued in the second year of her tenure as Dean of the Faculty of Law and, under her leadership, the Faculty sought to further enrich the students' experience, provide continuing legal education activities and to impact the wider society through numerous outreach initiatives.

ACCESS

STUDENT ACHIEVEMENT

Nine students from the Master of Laws (LLM) programme will graduate, one of whom completed with distinction in the Corporate and Commercial Law concentration. 174 undergraduate students from undergraduate programme have completed the LLB degree, 18 of whom were awarded with First Class Honours. During the 2020/2021 academic year, the Faculty continued to identify and implement strategies aimed at improving the students' experience. The 3rd Annual Faculty Awards Ceremony for the recognition of outstanding students in academia and co-curricular activities was held virtually for the first time on November 9, 2020 with 90 students being recognized in the categories of Subject Awards, Year/Level Awards, Top LLM Student Award and Dean's List Award. The Faculty had its first virtual hosting of its Sixth Annual Weekend Symposium on Law, Governance and Society under the theme 'Celebrating and Surviving - UWI Law 50 and Beyond' from November 21-22, 2020. The event, which is normally hosted in June, was pushed back due to the COVID-19 pandemic. For the first virtual staging, the symposium featured speakers from Canada, The USA, the UK, the Netherlands, Trinidad and Tobago and Jamaica. The presenters included members of academia, the judiciary and others in the legal fraternity. The keynote speaker was the Hon. Mr. Justice Adrian Saunders, President of the Caribbean Court of Justice. On March 22, 2021, the Faculty hosted its second annual Career Forum 2.0 virtually, which was geared towards increasing students' awareness about the various career paths available after completing the LLB degree. This took the form of a panel discussion with persons from various professions, some of the career options require the Legal Education Certificate (LEC) and others do not. The Faculty also celebrated its 50th anniversary and hosted a virtual reception in honour of the first graduates as part of the activities for the staging of the 7th Annual Symposium on Law, Governance and Society. This was held from June 25-27, 2021 under the theme Celebrating and Surviving: UWI Law 50 and beyond... The topics that were explored were Legal Profession and Judicial Ethics, the Law of the Sea, Sports Law and Tourism and the Law.

AGILITY

AI and IP in the Cultural and Creative Industries in Jamaica (May 2021 – ongoing)

Research England has allocated City, University of London ("City") funding as part of its Global Challenges Research Fund ("GCRF") and consequently City have approved the award of a maximum of £10,500 to the University of the West Indies ("UWI"), for the project titled Creative Artificial Intelligence and Intellectual Property In The Caribbean: Exploring Challenges and Opportunities.

The research will make the point that Jamaican IP laws, especially patent and copyright laws, can be modified to accommodate creativity enabled by Al. It will recommend modifications of such laws aimed at making the Jamaican IP legal system attractive to investors and talents in the field of music, art and literature (amongst others). The project will therefore have on impact on the creative, technological and business landscape of Jamaica.

The impact of the proposed research will be amplified by the involvement of CebAl, the National Centre for Creativity enabled by Al based at City, and funded by Research England. Professor Neil Maiden, Director of CebAl, will join the project as Co-Investigator.

CebAl's purpose is knowledge exchange, exploiting the knowledge generated by City's research. To deliver this knowledge effectively to different sectors, CebAl will begin to establish new business ecosystems in selected sectors. One of these sectors can the creative industries, which can exploit the planned research results. In each ecosystem, CebAl will collaborate with business partners and clients in the sector to encourage different forms of knowledge exchange that exploits Al and creativity.
