OVERVIEW

This was an outstanding year for the Institute as it continued to host a wide range of events, including a challenging annual conference held offshore in St Lucia, in honour of the hundredth anniversary of the birth of Nobel Laureate Sir Arthur Lewis, after whom SALISES is named. Among the main activities were:

- SALISES and University College of London hosted a Conference entitled 'Beyond Westminster in the Caribbean Critiques, Challenges & Reform' September 11–12, 2014.
- A Seminar entitled '1938 & Beyond Exploring the Roots and Legacies of Modern Jamaica' featuring Ewart Walters and Professor Colin Palmer. October 15, 2014.

- 3. The 9th staging of the SALISES, Caribbean Child Development Conference was held November 5–6th, 2014 at Jamaica Conference Centre, under the theme 'Promoting the Rights of Children with Disabilities'.
- 4. The aforementioned SALISES annual conference celebrated as the W. Arthur Lewis Centennial Conference, January 14–16, 2015 in Castries St. Lucia, under the theme 'Towards Caribbean Prosperity & Happiness in an Equitable & Sustainable World'
- A Global Forum to mark the 100th anniversary of the birth of Lewis with a ten site teleconference on January 23, 2015, with SALISES as the local site host. The forum was used to recognize Lewis' work and its continued relevance.
- 6. The book launch of former graduate student Dr. Annicia Gayle-Geddes' 'Disability and Inequality' on March 31, 2015.
- 7. A joint panel presentation with the UWI Museum on Lewis entitled 'Relevant as Ever in his Centenary Year: Illustrations from Caribbean Research' on April 1, 2015.
- 8. The SALISES Political Economy and Public Policy Cluster (PEPP) in association with Florida International University's Latin American and Caribbean Centre held a one day planning meeting of experts on April 1, 2015. The meeting was used to organize and plan for the implementation of a project of strategic collaboration focusing on economic growth, equity and stability in the English speaking Caribbean. Attendees included persons from the Central Bank of Suriname, Caribbean Congress of Labour, University of Guyana and CARICOM.

STAFF MOVEMENTS

Professor Mark Figueroa, joined SALISES in August 2014 as Professorial Fellow. Professor Brian Meeks who has served as SALISES Mona Director since 2009 and Regional Director since 2013, retired from both posts and from the University of the West Indies. Miss Helen Fox, Data Bank Manager also retired from SALISES this year. Dr Pat Northover returned

at the end of the year from Duke University where she had been resident as a Mellon Fellow from January 2015 and is starting her sabbatical for 2015–2016. Professor Patsy Lewis proceeded on Fellowship leave where she will be a Visiting Scholar at Brown University.

DOCUMENTATION CENTRE

Thelma White, Librarian

The Documentation Centre continued to cater to the staff and students of SALISES as well as members of the wider UWI community through its offerings of library and information services. Staff and graduate students were able to enjoy the facilities and services which included reference service, photocopying, interlibrary loans, and access to databases. External users, both local and international, including visiting researchers, alumni, local and overseas graduate students, have also utilized the services.

The year has been eventful with a few changes made to its infrastructure. A substantial weeding and reorganisation of the stacks was conducted to accommodate several donations of books and documents from outgoing members of staff including the Director. A corner in the reading area of the library was redone to improve the appearance and become more comfortable. The back of the wall was painted; and a re-upholstered chair and a wall painting were installed.

The Doc Centre continued its work on adding its collections to the ALEPH integrating system which was installed by Main Library. All the collections in the main reading area except books donated by research fellows for their students have been processed and added. Concentration will now be on books that were donated to the Doc Centre throughout the year.

Other highlights of the activities during the year included:

- The Doc Centre was renamed to Norman Girvan Documentation Centre. A new signage was mounted at the entrance and the old one removed.
- Periodic displays mounted throughout the period with two notable ones being
 - Posters to commemorate the 100th anniversary of the birth of Sir
 Arthur Lewis in St. Lucia

- SALISES Seminar "1938 and Beyond: Exploring the Roots and Legacies of Modern Jamaica"
- The SALISES was represented at the Mona Research Days held February 9–11, 2015 through the mounting of a display depicting the functions and activities of SALISES. The activity was coordinated by the Documentation Centre and Data Bank staff. Areas of focus at the booth were some 50/50 seminars, graduate work, the MSc programme, posters on Sir Arthur Lewis, the Annual Child Research conference, as well as a display of publications done by SALISES fellows and other members of staff.
- The Doc Centre was slated to become the repository for articles for UWIHARP. These articles relate to HIV/AIDS in the Caribbean. Training was held for staff on using the database and adding articles to the database.
- The collections received a substantial boost with the donations of books and other materials from professors Brian Meeks and Patsy Lewis and Dr Michael Witter.

A. Data Acquisition.

During the year, the Databank added the Jamaica Census 2011, the SLC 2012 and datasets from the National Council on Drug Abuse (NCDA) to its collection.

B. Data documentation

During the 2014/15 period, the Data Bank started to use an updated version of the cataloguing tool, NADA, for online documentation of all data sets. NADA is a free web-based cataloguing system that serves as a portal for researchers to browse, search, compare, apply for access, and download relevant census or survey information. Most of the data sets documented under the old Nesstar Publisher / CDRom Builder Microdata Management Toolkit were converted to NADA.
