OVERVIEW

The Department of Surgery, Radiology, Anaesthesia and Intensive Care (SURRADIC), remained forefront in the University Hospital of the West Indies, and by extension Jamaica's response to the COVID-19 pandemic. The Department did well to build on some of the lessons gained from the previous academic year in managing this pandemic, nevertheless all aspects of our operations were negatively affected, and it was obvious that both students and faculty were impacted. While some functions were in a 'holding' survival mode, like the rest of the campus we returned to faceto-face teaching and as reflected in the final MBBS examinations results, we excelled in the core function of teaching. We are actively addressing our research output which has lagged behind and is not yet at the pre-pandemic levels. The blended mode of delivery was honed by the full complement of staff and appreciated by our students with all lectures delivered in an efficient and effective manner. Tutorials and clinical teachings are now back to face-to-face in the clinical environments which is appreciated by both students and faculty. It is true that still some increase interactions in the virtual world remains compared to the pre-pandemic era including the various multidisciplinary meetings but the increase in the availability and use of technology allows for greater consultation and collaboration, again to our advantage of cost savings while maintaining guantity and guality.

Our research efforts albeit may not actually be reflected in the absolute number of manuscripts published, took the greatest hit from the Covid-19 pandemic. This is also based on the noticeable reduction in ongoing research and access to funding for such activities. Still the potential opportunities presented were not lost including exploring options for more outpatient treatment algorithms, greater efficiency of care and attention to the smoldering epidemic of chronic non-communicable diseases. Care was also taken to mitigate the impact of burn-out of staff and our postgraduate students while also putting appropriate support mechanisms in place to ensure for their mental health. This included seminars for the optimisation of coping skills, access counselling services and where necessary, greater support for 'mental health' days. It is safe to say that while the COVID-19 pandemic lingers, the resilience of the human spirit as manifested in the solutions to the challenges induced, are a light rising from the west. The Department of SURRADIC remains firmly grounded on the pillars of: teaching and education, research, clinical services, and outreach and infrastructure aligned with the University of the West Indies' guiding pillars of, Access, Alignment and Agility.

ACCESS

Teaching and Education

During the year under review our attention to our students focused with the return of face-to face teaching for our undergraduate students and more emphasis on competency based training in the clinical and simulated clinical environment for our postgraduates. The year in review saw the introduction of a monthly invited 'International Guest Lecture' from a full professor and also the competency-based 'Laparoscopic Surgical Skills for Surgeons' which introduced all our residents to the modern theory and practical skills of Laparoscopic Surgery. This course was introduced jointly with the Department of Obstetrics and Gynaecology. Again at the undergraduate level greater emphasis was placed on strengthening our clerkships, including the assessment processes, given their contribution to our students' final GPA. Throughout the academic year the various clinical clerkships progressed well culminating with the final MBBS examinations which were a success with greater than 90 percent of students achieving a pass and several with honours and the most distinctions in the final MBBS Surgery in the last two decades, with Mona students receiving all the significant Surgery Prizes across the Campuses.

Research

Our efforts at clinical research in the Department under the leadership of a Director of Research to coordinate interdepartmental projects, motivate efforts at obtaining grants and to reengage regional and international partners for collaborative studies were off to a slow start. Our joint application for a NIH grant for cancer research with the SUNY was unsuccessful, but efforts continue in this vein as collaboration with international partners is key for sustainable research. Data entry in the various Registries (Trauma, Colorectal Cancer, Brain Tumour) maintained by the Department continue and as these databases reach beyond the critical mass it is hoped that we shall see increased publications by virtue of the usage of the data accumulated there. It is however hoped that as we adapt to living with the pandemic and with the increasing use of electronic medical records at our institutions, this process with become less labour intensive, and may even be outsourced.

Our collaboration with partners for two clinical trials are ongoing: Use of Dibenzyl Trisulphide (active ingredient in Guinea Hen Weed) as a Chemotherapeutic Agent in the treatment of Stage Four Cancer, and XYZ in the management of chronic leg ulcers in patients with sickle cell disease.

Registries

Trauma Registry/Redcap A total of 1251 patient records have been entered in the Redcap database. Data entry and edits are ongoing. Colorectal Cancer Registry A total of 1807 patients have been entered. Intracranial (Brain) Tumor Registry A total of 1417 cases have been entered.

Clinical Services

The Department's overall activities have now adapted to the waves of the Covid-19 pandemic and this led to the mental and behavioural mindset of living with Covid-19, with its impact on clinical services and distribution of resources. The University Hospital and members of SURRADIC faculty continue to lead the national effort against the Covid-19 pandemic and restore clinical functions including dealing with the surgical backlog induced by this pandemic. As a result, our Emergency Medicine and Anaesthesia and Intensive Care Divisions remain overworked, but we are happy to report that there was an increase in the number of major surgeries done for cancer and other time sensitive or life threatening diseases. There was a reversal in the previously reduction in elective surgeries and demands on while the demands on Interventional Radiology saw a continued increase in its services. The surgical emphasis on cancer care and emergencies remain, with some return to planned activities such as renal and liver transplants and advanced laparoscopic cases. These we expect to continue on the upward trajectory in the upcoming academic year.
